Page 11 shows a big picture of the assets, liabilities and net postions, which shows there were no deficits. Berthiaume also read aloud pages 14, 16 and 21. The City received the standard un-modified opinion which is the highest score possibly earned. Berthiaume also mentioned that the city will need an additional audit work for federal funding received in the 2023/2024 Audit.

4. APPROVAL OF 2022/2023 FY AUDIT:

- 5. DISCUSSION/DIRECTION SOLID WASTE COLLECTION/CONTRACT: The Republic proposal would include a year one increase of 25.7% and this would be an increase of \$4.37 a month over the current contract. Increases each year after (years 2-5) would be 4.5% or CPI (whichever is lower). Republic contracts throughout the county are going to 4.5% as well as all being 5 years. Between 2009 and 2018 there was a 48% increase or 5.3% per year. What you see with the proposed increase is that the amount that would be billed would be smooth if approved at around 8% per year. So it is very close the what I had projected. The downside to the proposal besides the increase is that city would no longer be able to issue dump passes to residents once a month/per address. The township has an agreement with landfill operator for dump passes and no tipping costs which reduces the contract costs. I do know residents have come to appreciate having all these services including yard waste, bi-weekly recycling and the rolling carts. My suggestions to the proposal would be either:
 - That the city remove recycling and offer it as an opt-in service.
 - Request Republic to add a provision to the contract that would provide for heavy item
 pickup be added at no cost twice a year so residents who wish to dispose of larger
 items and residents could set them out without having to make a request.
 - Go out to bid. Please remember that time is crucial and that a new contract would require the collection of old carts and distribution of new carts.

I have provided the list of current contracts (costs, length, services) throughout the county. Discussion ensued on possible costs savings to offset the proposed increases coming from Republic. 2 free dump passes for 2-yards per year instead of 1 per month should be included in the RFP and possibly once a month 95-gallon recycling versus bi-weekly. Prior to the roll call vote Rankin recommended a special meeting due to the contract expiring December 31st.

- <u>MOTION</u> by Heslop <u>SECOND</u> by Arnold that we direct Neil to put this out for bid. Roll Call Vote: Pangle Aye, Arnold Aye, Martin Aye, Heslop Aye, Burch Aye, and Mayor Pro-Tem Richard Aye. All Ayes. Motion Carried.
- <u>MOTION</u> by Pangle <u>SECOND</u> by Burch to schedule a special council meeting on Thursday November 9th @ 8:00 p.m. to unseal and choose the bid for the solid waste contract. Roll Call Vote: Burch Aye, Arnold Aye, Martin Aye, Heslop Aye, Pangle Aye, and Mayor Pro-Tem Richard Aye. All Ayes. Motion Carried.

I have quotes for doors minus installation from Iversons, quote from Dover and am waiting on a quote from Davison overhead door. The DPW will be pouring concrete this week and should in the next week or two have the slab installed. I figure the garage door will take a few weeks to order and install and I would like to get installed by the time the snow starts to fly. I will provide a handout for council with quotes.
